Maintenance

- The interior greenbelts have been cleared, but need additional work removing branches near where Wood Duck bends.
- To protect privacy and prevent non-resident walkers, the perimeter greenbelts do not get cleared.
- The vegetation surrounding Turtle Pond has been cut down to 3 feet.
- Jennifer Smith Turner and Nila Gray have formed a committee to address clean-up of Turtle Pond.
- Janet Aram has volunteered to lead a committee to develop speedbump recommendations.
- Both committees will share progress/recommendations at the next Board meeting.
- Some of the community signs are outdated, mismatched or redundant. Betsy will survey the signs, remove outdated ones and recommend signs as needed. They will match the green and white signs that have already been installed.

Saltwater Dock

- An owner or renter must accompany guests when using the saltwater dock area.
- George Sourati will begin the permitting process to rebuild the current dock, which is old but still in usable condition. He estimates that it will take 2 years.

Kayaks

- Anyone needing a kayak sticker should contact Barrie.
- All kayaks must be on the racks, and only 2 kayaks per household are allowed.
- Owners of more than 2 kayaks should identify them all with stickers but rotate so only 2 are on the racks.
- Renters should notify Barrie if leaving kayaks near the racks and write their name on them
- Barrie had her landscaper remove some of the poison ivy near the kayaks.

- The courts will be resurfaced in spring 2026 when the temperature reaches 55-60 degrees.
